## Uniform Code Requirements (K-8)

### **MALE STUDENTS (K - 8)**

#### **PANTS**

- Pants or shorts in solid colors
- Colors must be black, tan (khaki), gray, yellow/gold, or white
- Only school or school district lettering or logos is permitted (Examples = "Bucs", "Interboro", "Prospect Park School", a pirate logo) EXCEPT brand or other logos or labels, which cannot be larger than 2" X 2" (Example = small Nike symbol or brand name)
- Lettering is allowed on the front and sides ONLY

#### **SHIRTS AND SWEATSHIRTS**

- Shirts and sweatshirts in solid colors
- Colors must be black, white, yellow/gold, or gray
- Style must be crew neck (non-collared shirt worn along the neck line) or collared (Polo or golf shirts with 2 to 3 buttons). Sleeveless shirts are not permitted.
- Only school or school district lettering or logos is permitted (as described above) EXCEPT brand or other logos or labels, which cannot be larger than 2" X 2"

### **FEMALE STUDENTS (K-8)**

#### **PANTS**

- Females may wear pants, shorts, skirts / skorts, or dresses in solid colors
- Pants, shorts, skirts / skorts must be fingertip length.
- Colors must be black, tan (khaki) yellow/gold, gray, or white
- Lettering (same as for males - see above)

#### **SHIRTS AND SWEATSHIRTS**

- Same as for males (see above)

### **FOOTWEAR**

Grades K - 2 - SNEAKERS ONLY

Grades 3 - 8 - SNEAKERS required ONLY on gym days, any other footwear is permissible

### **NOT ALLOWED**

- *No Slippers are permitted at any time for any grade*
- *No Pajamas are permitted at any time for any grade*

### **OTHER INFORMATION**

- Please write the student's name on all clothing items to insure misplaced clothing items can be returned to the student.
- There will be **no opting out** of the School Standard of Dress Policy except for religious reasons. Please discuss specific situations with the school principal.

The Interboro School District recognizes that the legislative authority to provide for a School Standard of Dress policy has been provided through Act 46 of 1998.

# Standard of Dress Requirements (Interboro HS)

## **SCHOOL DRESS**

We take pride in the appearance of our students. Your dress reflects the quality of the school, of your conduct, and your schoolwork. Therefore, it is recognized that parent(s) / guardian(s) must take the responsibility in the development of good habits in the area of safety, health, decency and cleanliness. It is also recognized that students as young adults must assume responsibilities for the implementation of an acceptable dress code. All students are expected to dress and groom themselves neatly, in clothes that are suitable for school activities. For special events like field trips, dances, Spirit Days, commencement and other ceremonial exercises, a mode of dress may be prescribed. School attire must meet reasonable standards of cleanliness, not endanger student or public health, not be disruptive to the educational process, and meet reasonable standard of appropriateness. Suggestions for appropriate dress include, but are not limited to, dress or casual shirts and pants, jeans, dresses, or skirts / shorts of proper length.

Examples of ***inappropriate*** dress:

- Hats, bandannas or other head gear worn or carried in building. These will be confiscated and may not be returned until the end of the school year.
- Bare or stocking feet
- See-through clothing or pajamas
- Heavy clothing normally worn only outdoors (unless inside temperature warrants the wearing of such clothing)
- Any apparel that over exposes the body, i.e. tank tops, torn sweat-shirts, net shirts, etc.
- Shirts promoting alcohol, drugs, violence, discrimination or other inappropriate topics
- Shorts and skirts that are excessively short, tight, or made of spandex or similar materials (Shorts that extend above the mid-thigh are considered inappropriate, should not be worn)
- Midriffs, low cut shirts, strapless, spaghetti straps, halters, or bare back shirts (Note: shirts must touch the top of the pants or skirts at all times)
- Clothing that is torn, or in any state of disrepair
- Clothing that is immodest, suggestive, distracting, or otherwise inappropriate for the school setting (Pants for males and females must be worn above the hip so as not to expose either midsections or undergarments)

In the case of dress code violations, the Interboro High School Administration will take one or more of the following courses of action:

- Have the student correct the violation immediately
- Contact the student's parent or guardian to assist in the immediate correction of the violation
- Contact the student's parent or guardian and have the student removed from the school premises
- Isolate the student for the remainder of the school day

In the case of persistent or willful violations, disciplinary action will be taken in accordance with the Student Handbook (see Insubordination).
