Living in a Multiple Occupancy situation means, that you live with a tax payer/home owner who resides in the Interboro School District. Families in this situation will complete the attached forms and have them notarized and bring in all the necessary documents.

The <u>tax payer/ home owner and guardian</u> are required to meet with the Registrar at the time of Registration. This packet is required to be completed annually.

Things to bring with you:

Tax Payer/Home Owner:

- Fill out the Multiple Occupancy Owner Form and have it Notarized
- Proof of Residency (Mortgage Statement, or Property/School Tax Bill)
- 1 Current Utility Bill (in owner's name) (Gas, Electric, Water, or Cable/Satellite) and an additional piece of mail.
- Photo ID presented at the time of Registration

Parent/Guardian:

- Fill out the Multiple Occupancy Parent/Guardian Form and have it Notarized
- Picture ID with matching address (update card / internet receipt is acceptable if change has been made.)
- Total of 2 pieces of mail: 1 current Utility Bill (Gas, Electric, Water, or Cable/Satellite) and an additional piece of mail. If all utilities are in the tax payers name, you will be required to bring in 2 pieces of mail (bank statement, credit card statements, etc)
