Instructions to School staff:

- 1. If the volunteer has lived in PA continuously for the past 10 years, they are not required to submit an FBI clearance.
- 2. If they obtained an FBI clearance at any time after establishing residency in Pennsylvania, they can submit a copy of that clearance.
- 3. If they have not lived here for 10 years and/or have not been previously cleared, they must submit all three clearances.
- 4. If they currently live in another state, they can qualify as a non-resident volunteer on a provisional basis (not to exceed 30 days in a calendar year) if they have been cleared under the laws of the state where they reside. In such case, they must provide the documentation of their clearances in the other state.
- 5. If the volunteer is seeking to waive the FBI clearance requirement, he/she must certify that he/she has no convictions of any of the offenses listed in 5(b), and have not been the subject of a founded report during the previous 5 years.
