ISD Virtual Academy Meals



Virtual Academy Meal Pick-Up 3:15-5:30 on Mondays at the students' Community School

- Virtual Academy Meal Pick-Up is Available to all Virtual Academy Students
- Parents/Guardians will need to use
 Student ID numbers to pick up their children's meals
- Families are Encouraged to fill out the Free and Reduced Lunch form as well
 - (this helps the district receive additional subsidies and families can receive subsidies from the government as well)

ISD Virtual Academy Overview: Programming According to Grade Band

K-2 & 3-5

- Synchronous and Asynchronous options
 - Daily Synchronous Homeroom
- Interboro teachers deliver a tailored Virtual Curriculum offered by our district-approved virtual provider. Interboro teachers will provide synchronous instruction and/or support students in asynchronous learning

6-8 & 9-12

- Students receive asynchronous instruction of a tailored Virtual Curriculum offered by our certified district-approved virtual providers
- Asynchronous Learning with Synchronous support
 - Monday Thursday 8 am 8 pm; Friday 8 am 4 pm
- Synchronous Advisory/Homeroom
 - 0 6-8
 - Twice a week Synchronous Advisory Period (Tuesday/Thursday)

ISD Virtual Academy Attendance

Synchronous

- Homeroom & Classes
 - Attendance for synchronous students will be taken in Homeroom and in their Synchronous classes (if they have synchronous classes)

Asynchronous

- % Complete in Classes
 - Attendance for asynchronous students will be based on percentage completed for student's classes. Students will need to meet a percentage complete benchmark each week (generally 3% per week) to be marked present.
 - For example: week 1 3% complete, week 2 6% complete

K-5 Virtual Academy Format - Synchronous

- Instruction in ELA, Mathematics, Science, & Social Studies will be provided by Interboro Teachers and/or Certified Instructors from our Approved Virtual Provider via Synchronous Zoom on a daily basis according to a set grade level schedule
 - Interboro Teachers & Edgenuity
- Specials will be offered asynchronously
- Students Attend daily Morning Meetings
 - K-2 Morning Meeting
 - 3-5 Morning Meeting

K-5 Virtual Academy Format - Asynchronous

Asynchronous Learning Model (***includes synchronous morning-meetings and synchronous check-ins according to a set schedule):

- Students complete coursework in ELA, Mathematics, Science, Social Studies, and
 Specials asynchronously according to a set schedule
 - i. Interboro Teachers & Edgenuity
- Students Attend synchronous daily morning meetings
- Students Attend synchronous meetings according to a set schedule

*Parents/Guardians are strongly encouraged to choose the Synchronous model; parents/guardians who choose the Asynchronous model will complete an addendum to the Virtual Academy Learning Agreement (to be provided upon enrollment).

6-8 Virtual Academy Format - Asynchronous

In the Interboro Virtual Academy - 6th-8th Grades, students will receive asynchronous instruction of a tailored Virtual Curriculum offered by our certified district-approved virtual providers.

- Interboro Virtual Academy 6th-8th Grades Asynchronous Learning Model (***includes synchronous Advisory periods):
 - Students complete coursework in ELA, Math, Science, Social Studies, and
 Specials asynchronously according to a set schedule
 - Students Attend a Synchronous Advisory period with an Interboro Teacher twice per week 3:30-4:30 PM
 - Students will have access to Drop-In Synchronous Zoom support with a certified teacher from 8 am - 8 pm Monday through Thurs and 8 am - 4 pm on Friday.

HS Virtual Academy

- In the Interboro Virtual Academy 9th-12th Grades, students will receive the instruction of a tailored Virtual Curriculum offered by a combination of Interboro Teachers and/or district-approved virtual providers.
 - The Interboro Virtual Academy will offer students in 9th 12th Grade different Synchronous or Asynchronous Learning opportunities depending on each student's individual course needs and requests.
- Students will have the opportunity to earn a full schedule of 7 credits in the Virtual Academy model to ensure that they remain on track for graduation.

Pupil Services - Rachel Lambert Director of Pupil Services

- IEPs, 504s, and EL Services
 - Format:
 - Students with IEPs and EL services may receive services in-person at their community school or the high school (depending on grade level)
 - Students with IEPs for ELA/Math may enroll in regular-ed ELA/Math and receive *support* from a Special Education teacher at a regularly scheduled time outside of school hours
 - Students receiving Speech services and Counselor Check-Ins may continue to receive those services Synchronously in a virtual setting or in-person
 - 504 Accommodations will continue to be met in the Virtual Setting to the best of our ability

Program Change

Requests to change a child's program from in-person to the Virtual Academy can be made on a rolling basis and will be reviewed individually via a parent/guardian meeting. After the start of the school year, parents/guardians who wish to change their child from the Virtual Academy to in-person learning must make their requests by the following dates:

K-5th Grade Students:

Request by Oct 4th to Change Programs on Nov 8th

Request by Jan 18th to Change Programs on Feb 17th

6th-12th Grade Students:

Request by Dec 20th to Change Programs on Jan 24th

Students may only change programs one time per school year.

PLEASE NOTE: The program change request windows were established to reduce the academic disruption students may experience when they switch programs, especially because their teachers usually change when program change occurs. K-8 Students changing back to in-person learning are not guaranteed a space at their Community School and may be placed in an alternate Community School.
