Dear Interboro School Community,

I hope this letter finds you and your family well. *The District has modified the calendar for the week of November 23rd for all in - person students to receive virtual learning from home. Please see the last page of this letter for details.*

We will be utilizing the time for our Custodial/Maintenance Department to perform extra precautionary measures to ensure everyone's health and safety in our buildings.

This includes:

- The installation of "desk shields" on all student desks
- The realigning and remarking of desks to ensure appropriate social distancing
- Additional disinfecting/sanitizing of the buildings

As you are aware, the number of cases within the county and within the boundaries of our District are continuing to increase. We are continuing to monitor these numbers and are working closely with the Chester County Health Department. I want to emphasize that this is a very fluid situation, and we need to be prepared in the event the District should need to switch back to virtual learning.

The factors that would be considered in the decision to return to an all virtual format are as follows:

- Mandated recommendations from the Department of Health (DOH), Pennsylvania Department of Education (PDE), and Chester County Health Department (CCHD) to return to an all virtual environment.
- If a confirmed and established linked - transmission(s) within or among schools occurred.
- If there was a far-reaching spread of the disease throughout the community, which could no longer be effectively contact traced by the CCHD.
- If there was a staffing shortage, which would prevent us from following our Health & Safety Plan.

If it were necessary to revert to virtual learning, our goal would be to provide parents, students, and staff with as much notice as possible.

In – person students should plan to return to school on November 30th unless you receive further information from the District.
