# PreK Counts Application Procedures

## **#1 SET APPLICATION APPOINTMENT**

Please set up an appointment to present your PreK Counts application via this [link](#).

## **#2 COMPLETE RECEIVED DOCUSIGN APPLICATION PACKET**

Once the appointment has been confirmed, you will be sent the application packet digitally via DocuSign. Please be aware that the sender of this packet will appear to be from DocuSign specifically. You must complete the application packet via DocSign prior to attending your scheduled application appointment.

## **#3 ATTEND THE APPLICATION APPOINTMENT WITH DOCUMENTS**

- Birth Certificate of child (must be 4 by 9.1.21)
- Current immunizations
- Financial Documentation (ALL applicable Household Income Documentation to validate that your family income is at or below 300 percent of the Federal Poverty Guidelines (W2, current tax forms, and/or one month's pay stubs for all members of the household, social security, SSI, unemployment compensation, child support, worker's compensation, alimony, TANF Cash payments)

Homeowner:

- current mortgage statement or tax bill
- Current utility bill
- Additional piece of mail
- Photo ID with current address

Renter:

- Current lease with your name and child's name, if not current also bring renewal letter
- Current utility bill
- Additional piece of mail
- Photo ID with current address

If you are living with a tax payer please complete the Multiple Occupancy packet, have it notarized and bring the required documents.

Please bring custody papers or foster paperwork when applicable.

# FINANCIAL ELIGIBILITY

Interboro's PreK program is funded through the Pennsylvania PreK Counts grant. ISD is required to follow state guidelines regarding eligibility. To be eligible for consideration for a slot in Interboro's PreK Counts program, the child's family income must be at or below 300% of the federal poverty level. To determine if your family is eligible, consider the size of the child's household and all sources of income. See Federal Poverty Level Guidelines relative to family size. Families will need to provide financial documentation at the time of their application appointment.
