ARP ESSER Health and Safety Plan Guidance & Template

Interboro School District - 2023-2024

Section 2001(i)(1) of the American Rescue Plan (ARP) Act requires each local education agency (LEA) that receives funding under the ARP Elementary and Secondary School Emergency Relief (ESSER) Fund to develop and make publicly available on the LEA's website a *Safe Return to In-Person Instruction and Continuity of Services Plan*, hereinafter referred to as a *Health and Safety Plan*.

Based on ARP requirements, 90 percent of ARP ESSER funds will be distributed to school districts and charter schools based on their relative share of Title I-A funding in FY 2020-2021. **Given Federally required timelines, LEAs eligible to apply for and receive this portion of the ARP ESSER funding must submit a Health and Safety Plan that meets ARP Act requirements to the Pennsylvania Department of Education (PDE) by Friday, July 30, 2021, regardless of when the LEA submits its ARP ESSER application.**

Each LEA must create a Health and Safety Plan that addresses how it will maintain the health and safety of students, educators, and other staff, and which will serve as local guidelines for all instructional and non-instructional school activities during the period of the LEA's ARP ESSER grant. The Health and Safety Plan should be tailored to the unique needs of each LEA and its schools and must take into account public comment related to the development of, and subsequent revisions to, the Health and Safety Plan.

The ARP Act and U.S. Department of Education rules require Health and Safety plans include the following components:

1. How the LEA will, to the greatest extent practicable, implement prevention and mitigation policies in line with the most up-to-date guidance from the Centers for Disease Control

and Prevention (CDC) for the reopening and operation of school facilities in order to continuously and safely open and operate schools for in-person learning.

2. How the LEA will ensure continuity of services, including but not limited to services to address the students' academic needs, and students' and staff members' social, emotional, mental health, and other needs, which may include student health and food services;
3. How the LEA will maintain the health and safety of students, educators, and other staff and the extent to which it has adopted policies, and a description of any such policy on each of the following safety recommendations established by the CDC:
 - a. Universal and correct wearing of masks;
 - b. Modifying facilities to allow for physical distancing (e.g., use of cohorts/podding);
 - c. Handwashing and respiratory etiquette;
 - d. Cleaning and maintaining healthy facilities, including improving ventilation;
 - e. Contact tracing in combination with isolation and quarantine, in collaboration with State and local health departments;
 - f. Diagnostic and screening testing;
 - g. Efforts to provide COVID-19 vaccinations to school communities;
 - h. Appropriate accommodations for children with disabilities with respect to health and safety policies; and
 - i. Coordination with state and local health officials.

The LEA's Health and Safety Plan must be approved by its governing body and posted on the LEA's publicly available website by July 30, 2021. * The ARP Act requires LEAs to post their Health and Safety Plans online in a language that parents/caregivers can understand, or, if it is not practicable to provide written translations to an individual with limited English proficiency, be orally translated. The plan also must be provided in an alternative format accessible, upon request, by a parent who is an individual with a disability as defined by the Americans with Disabilities Act.

Each LEA will upload in the eGrants system its updated Health and Safety Plan and webpage URL where the plan is located on the LEA's publicly available website.

The ARP Act requires LEAs to review their Health and Safety Plans at least every six months during the period of the LEA's ARP ESSER grant. LEAs also must review and update their plans whenever there are significant changes to the CDC recommendations for K-12 schools. Like the development of the plan, all revisions must be informed by community input and reviewed and approved by the governing body prior to posting on the LEA's publicly available website.

LEAs may use the template to revise their current Health and Safety Plans to meet ARP requirements and ensure all stakeholders are fully informed of the LEA's plan to safely resume instructional and non-instructional school activities, including in-person learning, for the current school year. An LEA may use a different plan template or format provided it includes all the elements required by the ARP Act, as listed above.

* The July 30 deadline applies only to school districts and charter schools that received federal Title I-A funds in FY 2020-2021 and intend to apply for and receive ARP ESSER funding.

Date of Last Revision: How will the LEA, to the greatest extent practicable, support prevention and mitigation policies in line with the most up-to-date guidance from the CDC for the reopening and operation of school facilities in order to continuously and safely open and operate schools for in-person learning?

The school district has implemented a health and safety plan throughout the 2020-2021 and 2021-2022 school years using mitigation strategies recommended by the CDC, PA Department of Health, CHOP Policy Lab, and during the 2020-2021 year, the Chester County Health Department. These strategies were successful in supporting the larger public health initiative to slow the spread of COVID-19 and to protect our district community, especially those at increased risk for severe illness. Further, our district supported vaccination clinics for our teachers and staff, led vaccine clinics for students, and implemented COVID-19 testing programs to support identifying potential exposures and to keep students and staffs in school.

Interboro School District will continue to review the latest guidance from the CDC, PA Department of Health, Delaware County Health Department, and CHOP Policy Lab in case new information is provided that the district should consider. **Of important note**, for the 2023 - 2024 school, the district will only implement mandates from the Pennsylvania Department of Education, PA Department of Health, CDC, or the Delaware County Department of Health. The district will rely on our board policy for communicable disease to guide responses to COVID-19. The chart below provides strategies, policies, and procedures to be used within the district.

1. How will the LEA ensure continuity of services, including but not limited to services to address the students' academic needs, and students' and staff members' social, emotional, mental health, and other needs, which may include student health and food services?

The district will operate all programs in an in-person format. The district will approve an *Emergency Instructional Time [Section 520.1 - 2022-23 School Year]*. This can be viewed on district website. This plan will guide any other strategies to be used to the educational programs offered.

<ul style="list-style-type: none"> • Universal and correct wearing of <u>masks</u>; 	<p>The district will not require masking for students, staff, volunteers, or visitors unless there PA Department of Health, CDC, or the Delaware County Department of Health. The district will encourage individuals who prefer to continue to wear a mask. It is highly encouraged for nonvaccinated individuals to wear masks in medium or high levels of COVID-19.</p> <p>Staff and students who travel to other locations to provide services or engage in extracurricular activities will adhere to the Health and Safety Plans of the other locations.</p>
<ul style="list-style-type: none"> • Modifying facilities to allow for <u>physical distancing</u> (e.g., use of cohorts/podding); 	<p>The district will continue to provide routine maintenance and repairs of school facilities. The district will continue to provide in-person for all educational programs. There will be no requirements for physical distancing for the 2024 school year.</p>
<ul style="list-style-type: none"> • <u>Handwashing and respiratory etiquette</u>; 	<p>Best practice encourages hand washing prior to meals and snacks, after meals and snacks, after coming from being outside, after using the bathroom, and after blowing nose, coughing, or sneezing. The district will encourage our students, staff, and contractors to implement these best practices.</p>
<ul style="list-style-type: none"> • <u>Cleaning and maintaining healthy facilities, including improving ventilation</u>; 	<p>The district utilizes EPA Approved Disinfectants for use against COVID-19. There will be no restrictions on the use of our buildings, classrooms, common areas, and office spaces.</p> <p>If there is a case of COVID-19, a cleaning and disinfecting of the area will take place.</p> <p>Ventilation – HVAC Systems will continue to run at COVID Mitigations recommendation intake, 20% recirculation.</p>
<ul style="list-style-type: none"> • <u>Contact tracing in combination with isolation and quarantine</u>, in collaboration 	<p>The district will not be performing contact tracing activities as these are the requirements of the health departments.</p> <p>The district may implement the Mask-to-Stay (MTS) strategy. MTS allows staff and students to continue to COVID-19 in school or in the community, and who are asymptomatic to continue to attend school with required mask-wearing at all times when around other people for ten days after the date of diagnosis.</p>

with the State and local health departments;	<p>Student, staff, or contractor, who has tested positive for COVID-19 shall notify their direct supervisor and principal immediately. COVID-19 is a communicable disease and reporting is required. The district will implement the board policy for communicable diseases in such a situation.</p> <p>The district will not provide a dashboard for COVID-19 cases. COVID-19 is a communicable disease and the board policy will govern how to respond.</p>
<ul style="list-style-type: none"> • <u>Diagnostic and screening testing;</u> 	<p>The district will follow its Communicable Diseases Policy for guidance on communicable diseases. COVID-19 is classified as such.</p> <p>The district will maintain adequate personal protective equipment for the nursing staff: gown, face shield, eye protection, gloves.</p> <p>The district recommends staff, contractors, and students to self-screen prior to reporting to work or school and stay at home if experiencing illness.</p> <p>Parents and guardians are recommended to self-screen their child prior to reporting to school and keep their child home if experiencing illness.</p> <p>Students, staff, and contractors shall report immediately to their immediate supervisor/principal if they are COVID-19 positive.</p>
<ul style="list-style-type: none"> • <u>Efforts to provide vaccinations to school communities;</u> 	<p>COVID-19 Vaccination is currently the leading public health prevention strategy to end the pandemic. People who are fully vaccinated against COVID-19 are at low risk of severe infection. The district encourages all staff, students, and family members to consider vaccinations as a key strategy.</p> <p>Upon request, the district will provide information to families on how to get a COVID-19 vaccine for their family member.</p>
<ul style="list-style-type: none"> • <u>Appropriate accommodations for students with disabilities with respect to health</u> 	<p>For students with disabilities with medical diagnosis that required a prescribed health and safety plan, the district may reconvene to develop a specially designed instruction or strategies meet the needs of the student.</p>
